

# Brief Introduction

## I. Main Content

Statistics in this chapter mainly show the basic information of administrative divisions of Beijing, main indicators for social and economic development of the city, and monitoring indicators for the 13<sup>th</sup> Five-Year Plan, number of corporate and industrial entities, non-public economy, small-, medium- and micro-sized enterprises, etc.

## II. Adjustment to Historical Statistics According to New Industrial Standards

(I) Changes to the main framework of the *Classification and Codes of National Economic Sectors* (GB/T 4754-2002) as compared with the previous version (GB/T 4754-94):

1. Sectors added: (1) information transmission, computer service and software; (2) renting and leasing activities and business services; (3) accommodation and restaurants; (4) management of water conservancy, environment and public facilities; (5) education; (6) international organizations.

2. Sectors with name or range changed: (1) agriculture, forestry, animal production and hunting, fishing; (2) mining and quarrying; (3) manufacturing; (4) transport, storage and post; (5) wholesale and retail trade; (6) finance; (7) scientific research, technical service, geological prospecting; (8) resident service and other service; (9) health care, social security, and social welfare; (10) culture, sports and recreation; (11) public administration and social organizations.

3. Sectors cancelled: (1) geological prospecting, water conservancy management; (2) other sectors.

(II) Compared with the previous (GB/T 4754-2002) version, the *Classification of National Economic Sectors* (GB/T 4754-2011) mainly involves the following framework changes:

1. Changes to the name of category: (1) The “electric

power, gas and water production and supply” is renamed “production and distribution of electricity, heating power, gas and water”; (2) the “information transmission, computer service and software” is renamed “information transmission, software and information technology services”; (3) the “scientific research, technical service and geological prospecting” is renamed “scientific research and development, technical services”; (4) the “resident service and other service” is renamed “resident services, repair and other services”; (5) the “health, social security and social welfare” is renamed “health care and social works”; (6) “public administration and social organization” is renamed “public administration, social security and social organizations”.

2. Changes to the order of categories: (1) the “wholesale and retail trade” is put before the “transport, storage and post”; (2) the “accommodation and restaurants” is put after the “transport, storage and post”.

3. Changes to the scope of category: (1) agriculture, forestry, animal production and hunting, fishing; (2) manufacturing; (3) transport, storage and post; (4) information transmission, software and information technology services; (5) finance; (6) renting and leasing activities and business services; (7) scientific research and development, technical service; (8) resident services, repair and other services; (9) education; (10) health care and social works; (11) culture, sports and entertainment; (12) public administration, social security and social organizations.

(III) Compared with the previous (GB/T 4754-2011) version, no adjustment has been made in the name of categories and the order of categories in the *Classification of National Economic Sectors* (GB/T 4754-2017) version.
